By bridging the gap between the community and various services, the advice center plays a significant role in fostering legal and social accountability.

The Role of the Advice Center

The advice center acts as a link between the community and essential services. It is strategically located at the central service point, ensuring easy access for those seeking assistance. This space is exclusively for women, providing a supportive environment for their empowerment.

At the advice center, community structures are established to facilitate effective management. Female champions lead these structures, bringing their expertise and dedication to the forefront. Their presence helps create an inclusive and empowering atmosphere.

The advice center offers a range of services to meet the diverse needs of survivors and individuals facing human rights violations. These services include:

Psychosocial Support:

Survivors can receive professional guidance and emotional support to help them cope with the trauma they have experienced.

•Legal Aid:

With the assistance of a legal officer, the advice center provides legal aid to survivors, ensuring they have access to justice and can navigate the legal system.

• Mediations:

JACKLYNE OVERCOMES ADVERSITY WITH THE HELP OF MIFUMI



Jacklyne Akinyi Otieno, a 20-year-old Kenyan woman, has faced numerous challenges in her life. She met Ivan Matalilo, a 24-year-old man from Uganda, while he was working in Kenya, and they had a daughter together. Despite falling in love and agreeing to become husband and wife in Uganda, Jacklyne later discovered she was Ivan's second wife.

After Ivan abandoned her and their two-year-old daughter, Jacklyne was left alone on a small plot of land with a dilapidated semi-permanent house and no means of support. Her plea for help fell on deaf ears, leaving her struggling to survive.

In February 2023, Jacklyne reported her situation to the police in Nyondo sub-county, but her case did not seem to be making any progress. She then went to Nabumali police station, where the Child Family Protection Unit (CFPU) in Mbale district was notified and asked for further assistance. This led to the involvement of MIFUMI staff, who provided Jacklyne with the necessary support and services to help her overcome her situation.

Upon learning of Jacklyne's plight, MIFUMI staff quickly ensured she received medical care and shelter, as well as psychosocial and legal support. They also conducted a social assessment and investigation, gathering information to help with legal proceedings.

Thanks to the efforts of MIFUMI staff and other technical officers, Jacklyne was reunited with her mother, who came from Kenya to take care of her and her daughter. The MIFUMI team helped with documentation and provided support in case of further legal action. Jacklyne was overjoyed to be reunited with her mother and daughter, and she expressed gratitude for the kind of support MIFUMI provided. Although Ivan, the man responsible for Jacklyne's problems, is still on the run, the MIFUMI team, along with police and community volunteers, are tracing him. Meanwhile, MIFUMI has initiated a request for start-up capital to help Jacklyne rebuild her life and move forward.

Jacklyne's story is an inspiring example of how perseverance, community support, and professional assistance can help individuals overcome adversity and achieve success. Thanks to MIFUMI's timely intervention, Jacklyne and her daughter are now on the path to a brighter future.


